Sisal, through the Risk Based Approach, also constantly analyses ICT risks and identifies appropriate mitigation actions in order to reach an acceptable residual risk level.

Sisal considers the effective application of the Information Security Management System to be a commitment and responsibility of the entire organisation and calls upon all personnel, at every level and grade, to comply with the principles contained in this Policy within the scope of their respective competencies and responsibilities.







## THE COMMITMENT OF SISAL S.p.A.

The Policy defines the commitment of Sisal S.p.A. and its Italian and foreign Subsidiaries to:

- guarantee a ensure central security governance aimed at preserving the confidentiality, integrity and availability of information assets:
- promote the development and continuous evolution of technological security solutions, adopted and to be implemented, for ensuring a sustainable advantage, lasting over time and in line with corporate objectives and values;
- promote the establishment of an adequate organizational model for the management of information security in line with the corporate growth objectives and promote the development of skills in order to keep the protective measures effective;
- manage activities in compliance with legal and regulatory requirements and specific contractual agreements with the various stakeholders, and turning their expectations and needs into requirements to be met;
- promote innovation in the field of security in order to ensure constant alignment with technological evolution and the use of new generation IT methods, processes and solutions;
- guarantee the security, resilience and protection of data in the context of the services offered to consumers and customers with a view to increase its reliability;
- spread, within Sisal S.p.A., culture and awareness on information security issues and cyber risks in order to increase the degree of awareness in relation to behaviours and guidelines to be followed for avoiding the occurrence of threats;
- promote the adoption of a risk-based approach in relation to the adoption of security measures through the use of a framework integrated into the overall corporate risk management model.

In order to implement the strategic objectives and guidelines, the Top Management considers the Information Security Management System a basic element of business management, identifying and managing risk factors and risks in a systemic way opportunity.
